FUND OVERVIEW

The Fund is a multi-manager solution that aims to maximise capital growth by investing directly or indirectly into Chinese equities and equity-related securities.

The Fund seeks to outperform its benchmark over rolling three-year periods. Exposure is gained primarily through investment into collective investment schemes.

RisCura aims to select managers and create a combined portfolio that can deliver consistent outperformance in most market environments. The Fund has exposure to managers based in mainland China as well as offshore. It is suitable for investors with a long investment horizon who are seeking significant long-term real returns but can tolerate volatility in the interim.

The Fund is regulated by the Central Bank of Ireland and is open to institutional investors.

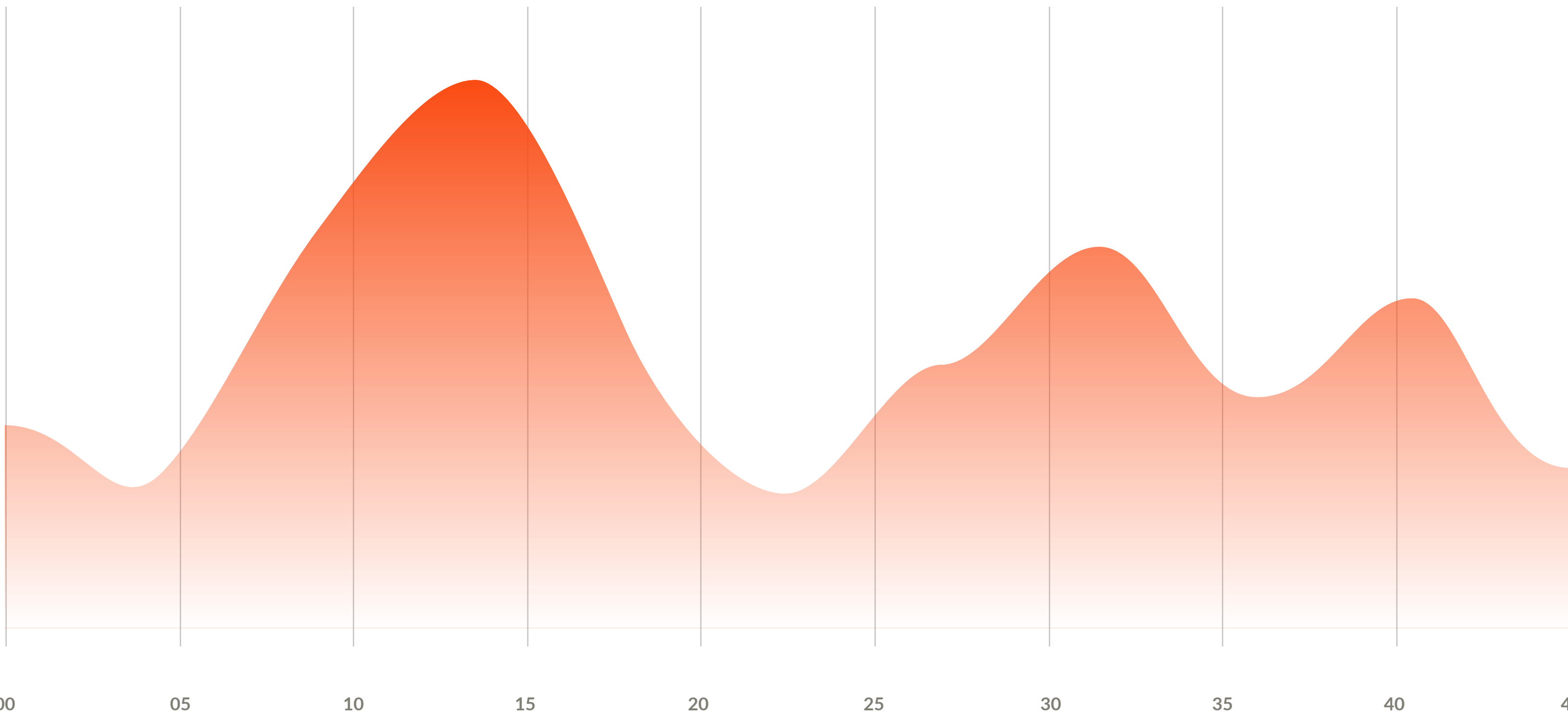
